# AN ORDINANCE AUTHORIZING CHANGE ORDERS TO CONTRACTS APPROVED BY THE TRANSIT BOARD

WHEREAS, Contracts originally approved by the Transit Board now require approval of contract change orders that are either an amount in excess of 10% of the original value of the contract or a cumulative amount in excess of \$100,000; now, therefore:

   Change Order No.2 provides for a funding increase and a contract time extension
   to allow the Authority time to competitively procure replacement services.

   Revised Contract Amount: \$1,720,794.75
- 1.2 Contract B010P01728 Unisys Corporation Original Ordinance No. 001-124 Description: Provision for software and hardware maintenance and support services for the Unisys Enterprise Server, Model IX5600 Change Order No. 1 provides for a time extension and contract increase to this contract to allow coverage to remain until the replacement dual platform Microsoft/Clearpath Unisys Enterprise server can be fully installed and a successor maintenance contract can be executed. - 1.5 C01FI9075 Teng & Associates, Inc. Original Ordinance No. 001-152 Description: Professional Architectural/Engineering Consulting Services for design and construction phase services for the Expand Capacity-Brown Line Project at Diversey, Wellington, Southport, and Paulina stations Change Order No. 11 to Phase III compensates the consultant for the cost of personnel attending the value engineering workshop because it is outside the contract scope of work. Total Change Order No. 11 to Phase III: \$1,984.41

Change Order No. 12 to Phase III provides for wide-flange steel beams, which will result in improved bent stress support and be significantly less expensive to construct.

Total Change Order No. 12 to Phase III: \$15,896.87

Change Order No. 13 Phase III provides for the transfer of bid phase services. Bid phase services consist of printing bid documents, preparing responses to written inquiries during the bidding period, preparing and printing addenda regarding clarifications to documents prepared by the consultant, and attending pre-bid meetings and other similar services as directed by the CTA.
