

ORDINANCE NO. 002-193

AN ORDINANCE MODIFYING #30  
SOUTH CHICAGO AND #95E 93<sup>RD</sup>-95<sup>TH</sup>  
BUS SERVICE

---

WHEREAS, A cul-de-sac was constructed on 92<sup>nd</sup> Street requiring new routings for the #30 and #95E bus routes; and

WHEREAS, The new routings were implemented on a temporary basis with the completion of the cul-de-sac; and

WHEREAS, The new routings have had little impact on CTA's customers and on the Authority's operational requirements and staff recommends that they be made permanent; now, therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD  
OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. The Chicago Transit Board hereby authorizes the implementation of the following bus service modifications:

**#30 South Chicago**

Operate certain trips from the present north terminal over and along the present southbound route to E. 92<sup>nd</sup> Street and S. Buffalo Avenue, north on S. Buffalo Avenue to E. 91<sup>st</sup> Street, east on E. 91<sup>st</sup> Street to S. Mackinaw Avenue, south on S. Mackinaw Avenue to S. Ewing Avenue, southeast on S. Ewing Avenue, and continuing to the present south terminal over and along the present southbound route and returning to the present north terminal over and along the present northbound route to E. 92<sup>nd</sup> Street and S. Mackinaw Avenue, north on S. Mackinaw Avenue to E. 91<sup>st</sup> Street, west on E. 91<sup>st</sup> Street to S. Buffalo Avenue, south on S. Buffalo Avenue to E. 92<sup>nd</sup> Street, west on E. 92<sup>nd</sup> Street, and continuing to the present north terminal over and along the present northbound route.

**#95E 93<sup>rd</sup>-95<sup>th</sup>**

Operate certain trips from the present west terminal over and along the present eastbound route to E. 92<sup>nd</sup> Street and S. Burley Avenue, north on S. Burley Avenue to E. 91<sup>st</sup> Street, east on E. 91<sup>st</sup> Street to S. Buffalo Avenue, south on S. Buffalo Avenue to the east terminal and returning south on S.

Buffalo Avenue to E. 92<sup>nd</sup> Street, west on E. 92<sup>nd</sup> Street and continuing to the present west terminal over and along the present westbound route.

SECTION 2. These changes shall be implemented when the necessary operating arrangements have been completed.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
