MINUTES: Finance Audit and Budget Committee. June 11, 2014.

ROLL CALL: Chairman Silva, Peterson, Robinson, Grimshaw, Lewis, Irvine, and Sen. There was a quorum of seven committee members present.

COMMITTEE ACTION: The committee reviewed the Finance report the 2013 Independent Auditor's report, and approved the May 14, 2014 committee minutes.

Then, after extensive review by the committee, of all other agenda items, Chairman Silva asked for a motion to place the recommended approved items on the omnibus for Board approval. Two agenda items were deferred from Committee and neither reviewed nor discussed. These two agenda items not reviewed and not placed on the omnibus for approval were an ordinance authorizing acquisition of real property at 9411-9413 S. State Street and an ordinance authorizing execution of a Collective Bargaining Agreement with the International Association of Bridge, Structural, ornamental and Reinforcing Ironworkers Local Union No. 1.

Mr. Sen moved for approval of the omnibus, as stated, and the motion to approve the omnibus was seconded by Mr. Irvine. The motion to approve the omnibus, and to recommend to the Board approval of the omnibus, passed with seven yes votes. The recommended omnibus contained the following items:

- An ordinance authorizing the execution and delivery of one or more supplemental indentures under which the Chicago Transit Authority may issue one or more series of corporate purpose debt obligations payable from the Sales Tax Receipts fund; authorizing the issuance of Sales Tax Receipts Revenue bonds, Series 2014, and making other provisions with respect to said bonds.
- 2 An ordinance authorizing the borrowing of a TIFIA Loan and issuance of a TIFIA Bond not to exceed \$350 million dollars, plus accrued interest, and the execution and delivery of a farebox receipts amended and restated master trust indenture, a second supplemental indenture and a TIFIA loan agreement and the making of other provisions with respect to said TIFIA loan, all for the purpose of paying certain costs associated with the rail fleet renewal project.
