ORDINANCE NO. 006-165

AN ORDINANCE AUTHORIZING
EXECUTION OF A COLLECTIVE
BARGAINING AGREEMENT
CONTAINING THE TERMS OF THE
AGREEMENT BETWEEN THE
CHICAGO TRANSIT AUTHORITY AND
THE CRAFT UNION COALITION

WHEREAS, The Metropolitan Transit Authority Act (70 ILCS 3605/28a) provides that the Chicago Transit Board has the right to deal with and enter into collective bargaining agreements with employees represented by a labor organization; and

WHEREAS, The following unions are known as the Craft Union Coalition:

- 1. International Association of Machinists, District 8;
- 2. International Brotherhood of Electrical Workers, Local 9;
- 3. Bricklayers and Stonemasons, Local 21;
- 4. Sheet Metal Workers, Local 73;
- 5. Chicago Journeymen Plumbers, Local 130;
- 6. International Brotherhood of Electrical Workers, Local 134;
- 7. International Brotherhood of Painters and Allied Trades, Local 8A-28A;
- 8. Pipe Fitters Association, Local 597;
- 9. United Brotherhood of Carpenters and Joiners of America, Chicago District Counsel;
- 10. Welders and Blacksmiths, Local 1247;
- 11. United Steelworkers of America, Local 9777; and

WHEREAS, On Monday, October 9, 2006, the Chicago Transit Authority and the Craft Union Coalition reached a tentative agreement on the terms of new, 3-year Collective Bargaining Agreements (also known as the Wage and Working Conditions Agreements) with its member units effective January 1, 2004, through December 31, 2006; now, therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. That the Chairman of the Chicago Transit Board, or her designee, is hereby authorized to execute the Wage and Working Conditions Agreements between the Chicago Transit Authority and the members of the Craft Union Coalition, with an expiration date of December 31, 2006. Said Wage and Working Conditions Agreement shall reflect the terms of the October 9, 2006, tentative agreement between the Chicago Transit Authority and the Craft Union Coalition as ratified by the Craft Union Coalition.

SECTION 2. That the Chairman of the Chicago Transit Board, or her designee, and/or the President of the Chicago Transit Authority, or his designee, shall be authorized to apply such terms of the above-referenced Wage and Working Conditions Agreements as they deem appropriate to non-bargained-for employees of the Chicago Transit Authority.

SECTION 3. This ordinance shall be in full force and effect from and after
