

ORDINANCE NO. 009-146

AN ORDINANCE AUTHORIZING  
REDUCTIONS IN FORCE TO MEET 2010  
OPERATING BUDGET REQUIREMENTS

WHEREAS, The Metropolitan Transit Authority Act, 70 ILCS 3605/28 (“the Act”) grants to the Board the authority to “reduce the force of employees for lack of work or lack of funds as determined by the Board”; and

WHEREAS, The Calendar Year 2010 Operating Budget includes a reduction in CTA labor and other expenses related to a reduction in service in the amount of \$100 million; and

WHEREAS, CTA has presented to the Board a recommendation to reduce the force of employees in order to meet the requirements of the Calendar Year 2010 Operating Budget, which reductions are set forth in Attachment A to this Ordinance; now, therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD  
OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. The Board hereby approves a reduction in force in those positions listed in Attachment A to this Ordinance in an amount up to the numbers contained therein.

SECTION 2. Notwithstanding the above, nothing in this Ordinance shall be construed to conflict with the rights of employees as set forth in the Act or any employee covered by a collective bargaining agreement.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
