ORDINANCE NO.010-62

AN ORDINANCE DECLARING PUBLIC BIDDING DISADVANTAGEOUS AND AUTHORIZING THE PLACEMENT OF PRINT ADVERTISEMENTS IN SELECT NEWSPAPER PUBLICATIONS TO PROVIDE ADVERTISEMENTS AND NOTICES FOR CTA CUSTOMERS

WHEREAS, From time to time, the CTA must place advertisements and/or notices in newspapers in order to notify CTA customers of service related matters, promotional programs and other initiatives; and

WHEREAS, The CTA wishes to develop an pool of newspapers in which to place such advertisements and notices; and

WHEREAS, Advertisements and notices will be placed in some or all of the newspapers identified on Exhibit A, attached hereto, and additional publications may be added to those on Exhibit A as needed to notify the greatest number of customers; and

WHEREAS, Staff recommends that disadvantageous to public bidding contracts be awarded to the vendors identified on Exhibit A so that the CTA can compensate them for future advertisements, if any, required by it; and

WHEREAS, Section 54.3-5 of the Regulations Governing Purchase and Sales Transactions provides for the award of contracts in those situations where the Transit Board determines that competitive bidding would be disadvantageous; now, therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. That based on the statements set forth in the preamble of this ordinance, the Chicago Transit Board hereby determines that competitive bidding for this service is disadvantageous.

SECTION 2. That the Chairman of the Board, or his designee, is hereby authorized to enter into contracts with each of the publications listed on Exhibit A for the possible future placement of advertisements and/or notices in them in a total amount for all publication that will not exceed Five Hundred Thousand Dollars (\$500,000.00), under Requisition No. B100P04005.
