

ORDINANCE NO. 008-136

AN ORDINANCE AUTHORIZING AN  
AGREEMENT FOR THE PLACEMENT  
OF ONE TRANSIT CARD VENDING  
MACHINE AT NORTHWESTERN  
MEMORIAL HOSPITAL LOCATED AT  
250 E. SUPERIOR, CHICAGO,  
ILLINOIS

WHEREAS, Northwestern Memorial Hospital ("Northwestern") operates the Prentice Women's Hospital, (the "Premises"), located at 250 E. Superior, in Chicago, Illinois; and

WHEREAS, The Chicago Transit Authority (the "Authority"), operates a transportation system in the Chicago metropolitan area and, in connection therewith, installs, operates and maintains Transit Card Vending Machines (each a "TCVM"), which dispense automated fare media usable on Authority's buses and trains; and

WHEREAS, The Authority installed one TCVM at Northwestern's Feinberg Pavilion 10 years ago, which is insufficient to service all of the Authority's customers in the area; and

WHEREAS, The Authority wishes to install a second TCVM at the Premises and Northwestern wishes to have the Authority install the TCVM at the Premises for the convenience of its passengers and other Authority customers who visit the Premises and the Northwestern staff members who work at the Premises; and

WHEREAS, The Authority will receive all revenues generated from the TCVMs installed at Northwestern's Prentice Women's Hospital facility and its Feinberg Pavilion; and

WHEREAS, The Authority will be financially responsible for communication, maintenance, installation and removal costs associated with the TCVMs and any costs associated with the installation and removal of any electrical and communication lines necessary for the operation of the TCVMs; and

WHEREAS, Each party will indemnify the other, against any claims for property damage and personal injury arising from the placement, existence, use, maintenance or removal of the TCVMs; and

WHEREAS, Northwestern will be financially responsible for all electrical costs related to the operation of the TCVMs; now, therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD  
OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. The Chairman, or her designee, is authorized to enter into an Agreement with Northwestern Memorial Hospital to place one additional TCVM at Northwestern's Prentice Women's Hospital facility in addition to the TCVM at Northwestern's Feinberg Pavilion, substantially in conformance with Exhibit A, attached hereto.

SECTION 2. This ordinance shall be in full force and effect from and after its passage.
