

ORDINANCE NO. 016-2

AN ORDINANCE AUTHORIZING
ACCEPTANCE OF A ZONING BONUS
CONTRIBUTION PURSUANT TO THE
CITY OF CHICAGO ZONING
ORDINANCE (BROWN/PURPLE LINE)

WHEREAS, The Authority's public transit system is directly impacted by increased ridership generated by development in the downtown Chicago area; and

WHEREAS, The Metropolitan Transit Authority Act, 70 ILCS 3605/8, authorizes the Authority to acquire property and rights useful for its purposes by gift or otherwise; and

WHEREAS, Section 17-4-1020 of the Chicago Zoning Ordinance provides a means by which developers in the downtown Chicago area can contribute funds to the Authority for improvements and repairs to public transit infrastructure located in proximity to, and therefore impacted by, their development projects and receive floor area ratio bonuses for such development projects; and

WHEREAS, Illinois Franklin LLC (the "Developer") and Order of Friar Servants of Mary, USA Province, Inc. (the "Owner") have filed an application with the City of Chicago (the "City") seeking planned development ("PD") approval for certain property commonly known as 301-331 West Illinois Street, Chicago, Illinois (the "Property"), which, if approved by the City Plan Commission and City Council, will allow for construction of a 24-story mixed-use residential and retail building on the Property; and

WHEREAS, Subject to approval by the City Plan Commission and City Council, the PD will permit the Developer to take a floor area ratio bonus in return for the Developer's contribution to the Authority of cash in the amount of One Million One Hundred Six Thousand Nine Hundred Ninety-Two Dollars (\$1,106,992.00) (the "Contribution") to fund all or a portion of certain transit improvement projects; and

WHEREAS, The Developer and the Authority wish to set forth the terms and conditions of the Developer's payment of the Contribution to the Authority, the transit improvements that will be funded and the Authority's oversight of the transit improvements as described in Exhibit A hereto; now therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD
OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. The Chairman of the Transit Board of the Chicago Transit Authority, or his designee, is hereby authorized to enter into an agreement to accept the amount of One Million One Hundred Six Thousand Nine Hundred Ninety-Two Dollars (\$1,106,992.00) from Illinois Franklin LLC and which contains such other terms and conditions as are substantially in conformance with Exhibit A hereto.

SECTION 2. The Chairman, or his designee, is further authorized to execute all documents necessary to complete the transaction as contemplated herein.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
