AN ORDINANCE AUTHORIZING AN  
INTERGOVERNMENTAL AGREEMENT  
BETWEEN THE CHICAGO TRANSIT  
AUTHORITY AND THE CITY OF CHICAGO  
BY AND THROUGH ITS DEPARTMENT OF  
TRANSPORTATION, FOR FY2011 GRANT  
FUNDS FOR THE CITY'S BIKE SHARE  
PROGRAM

WHEREAS, The Chicago Transit Authority ("Authority") currently operates a public transportation system in the city of Chicago; and

WHEREAS, The City of Chicago Department of Transportation ("CDOT") implements various programs to keep the city's surface transportation networks and public ways safe and sustainable for its users, and provides a variety of quality transportation options in the city; and

WHEREAS, The Authority and CDOT have partnered in previous projects to improve and connect various modes of transportation in the Chicago metropolitan area; and

WHEREAS, In Fiscal Year 2011, the U.S. Department of Transportation ("USDOT") distributed \$526,944,000.00 through its Transportation Investment Generating Economic Recovery discretionary grant program ("TIGER Grant Program") nationwide under the provisions of the Full-Year Continuing Appropriations Act of 2011 to invest in road, rail, transit and port projects that have a significant impact on the nation or a particular region or metropolitan area; and

WHEREAS, On November 30, 2012, the Authority and USDOT entered into a grant agreement, award number IL-79-0004-00, for a grant in the amount of Twenty Million Dollars (\$20,000,000) (the "Grant Agreement"); and

WHEREAS, The grant was awarded to the Authority to support specified projects to be implemented by each of the Authority and CDOT; and

WHEREAS, The projects to be undertaken include the CDOT Bike Share Program at cost of \$4,072,800.00; and

WHEREAS, The parties wish to express their intention to cooperate in matters relating to the FY2011 TIGER Grant Program award in order to improve and connect various modes of transportation in the Chicago metropolitan area through entry into an intergovernmental agreement; and

WHEREAS, The intergovernmental agreement will also permit the Authority to pass-through \$4,072,800.00 to CDOT to implement its Bike Share Program; now, therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD  
OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. That the Chairman of the Chicago Transit Board, or his designee, is hereby authorized to enter into an intergovernmental agreement with the City of Chicago, acting through its Department of Transportation, substantially in the form of the agreement attached hereto as Exhibit A, for a term which shall commence on the date of its execution and expire when the U.S. Department of Transportation provides a close-out notice for the Grant Agreement or on September 30, 2018, whichever is later, and through which the Authority will pass through TIGER Grant Program funds to the Chicago Department of Transportation for its Bike Share Program in accordance with the terms of the Grant Agreement.

SECTION 2. This ordinance shall be in full force and effect from and after its passage.
