

## **Chicago Transit Authority's Citizens Advisory Board**

## What is the Citizens Advisory Board?

The Citizens Advisory Board (CAB) was created by the Illinois General Assembly in November of 1983. The purpose of the CAB is to advise the Chicago Transit Authority of the impact of its policies and programs on the communities it serves.

The CAB is established by the Chicago Transit Board, and includes representatives of community organizations, commercial and business groups, and senior citizens with an interest in public transportation. Chosen from throughout the CTA service area, the eleven appointed volunteers serve a two year term.

The CAB meets on a quarterly basis at CTA Headquarters, 567 W. Lake Street, Chicago, IL 60661 or virtually via Zoom.

## **The Application Process:**

Due to the nature and purpose of the CAB, it is important that its members represent a cross section of the interests of the transit community in the CTA service area. Members of the CAB will be selected by the Chicago Transit Board from amongst the pool of interested applicants. As provided in the State law that created the CAB, the appointed members to the CAB should, to the greatest extent possible, reflect the ethnic, cultural, and geographic diversity of all persons residing within the CTA's service area.
