followed by a comment period,
during which members of the
public can ask questions or
provide input on the proposed
Transit TIF.

What is a Transit TIF?

In June 2016, the Illinois General Assembly approved a new financial tool known as Transit Tax Increment Financing or the Transit TIF. The Transit TIF is an economic development tool to support investment in large-scale, long-term transit projects. The Chicago Transit Authority (CTA) is seeking a Transit TIF designation for the Red Line Extension Project. The Transit TIF is needed in order for CTA to seek as much as \$2 billion in federal funds for the much-needed extension south of 95th/Dan Ryan.

What is the Red Line Extension Project?

The CTA is proposing to extend the Red Line from the existing terminal at 95th/Dan Ryan to 130th Street, subject to the availability of funding. The proposed 5.6-mile extension would include four new stations near 103rd Street, 111th Street, Michigan Avenue, and 130th Street.

Multimodal connections at each station would include bus, bike, pedestrian, and park & ride facilities.

This project is one part of the Red Ahead Program to extend and enhance the entire Red Line.
