


February

[WASHINGTON, D.C.] – U.S. Senator Tammy Duckworth (D-IL) and U.S. Senate Majority Whip Dick Durbin (D-IL) today announced that \$350 million has been slated from the Department of Transportation's (DOT) Federal Transit Administration (FTA) to help continue the progress on the Chicago Transit Authority's (CTA) Red Line Extension project. The Red Line Extension is one of the 18 major transit projects recommended for funding today in President Biden's Fiscal Year (FY) 2024 Budget Request to Congress.

Biden Administration's Proposed Budget Includes \$350 Million for Red Line Extension Project

The City of Chicago and the Chicago Transit Authority (CTA) are thrilled that the Red Line Extension (RLE) Project – one of the most transformational investments in agency history – has been included in President Biden's Budget Recommendation for Fiscal Year 2024. The inclusion of this significant level of funding in the President's Budget Recommendation reflects the importance of the RLE Project – not solely as a necessary transportation investment, but as a project that meets the Biden Administration's goals for infrastructure investments that foster equity and inclusion. If added to the final Congressional budget and approved, the \$350 million capital grant will continue adding momentum to this transformative project.



Red Line Extension Community Spotlight: Ware Ranch Steak House Re-Opens!

Since 1969, the Ware Ranch Steakhouse, located at 11147 S. Michigan Ave., has been a landmark in the Roseland community. Countless customers have dined at the restaurant since childhood, holding many memories of first dates, graduations, and after-church gatherings. In 2018, Judy and Victor Ware bought the business from the original owners, renovating the entire restaurant, including updating the kitchen and second floor to serve as a future event space. The restaurant boasts an extensive breakfast, lunch, and dinner menu, including customer favorites such as pancakes, French toast, and the famous "John Wayne" and "Roy Rogers" steak dinners!

When asked about RLE, the Wares, who are longtime residents of the area, are excited and looking forward to the


opportunities that the RLE and future development within the project area will bring to Roseland and surrounding neighborhoods. "RLE will help drive businesses to the area, giving folks a place to eat and shop," said Judy, who added she also believes the RLE will bring increased support to the businesses currently in the Roseland community.

Following a break-in and two fires that caused significant damage in 2020, the couple rebuilt the restaurant again and re-opened in early 2022. Despite these setbacks, the couple remains optimistic about the future of the steakhouse, one of few sit-down restaurants in Roseland. Their commitment to the restaurant demonstrates their dedication to the neighborhood.



CTA announced the agency selected three qualified contracting teams to submit design-build proposals for project construction.

CTA anticipates awarding the design-build contract in 2024.

Biggest news of the year: The federal government announced the RLE project is in line for \$1.973 billion in critical grant funding needed to build the project!



The RLE project won the Federal Transit Administration (FTA)'s Outstanding Achievement Award for Excellence in Environmental Documentation for our Final Environmental Impact Statement (EIS) and Record of Decision (ROD).
