#157 Streeterville/Taylor - Proposed



 Provide a one-seat ride between the West Side, Illinois Medical District, University of Illinois - Chicago and the Loop, Michigan Avenue and Streeterville

Minimize overlapping service in the Clinton/Canal corridor

#38 Ogden/Taylor #157 Streeterville



#55W West 55th - Proposed



- Provide more frequent peak period service
- Offer midday and Saturday service on Austin and 59th
- Avoid train crossing south of 59th
- Maintain half-mile spacing between 59th and 63rd

#55N 55th/Narragansett #55A 55th/Austin





#18 16th/18th*



- Implement midday service
- Adjusted routing to serve Roosevelt in December 2008
- Strong ridership growth on the weekend
- Funded by Job Access Reverse Commute grant

*Part of South Loop/Near South Side Experiment

#53A South Pulaski



- Extend Saturday and Sunday/holiday service until approximately 11:00 pm
- Eliminate a two-mile gap after 8:30 pm
- Improve weekend frequency
- Funded by a Job Access Reverse Commute grant

Extend route to Ford City Mall

- Provide connection to employment and shopping at Ford City and along Pulaski
- Improve transit connections to Daley Community College
- Funded by a Job Access Reverse Commute grant
