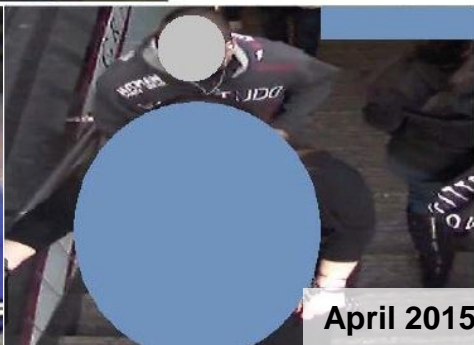

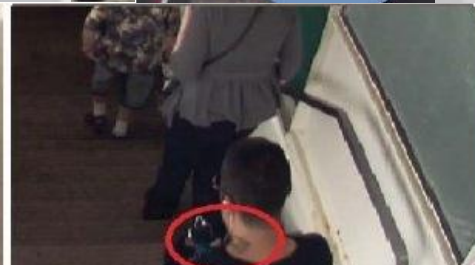

CTA cameras were an invaluable tool in the investigation of multiple incidents involving this offender. In September, this offender was arrested and charged after allegedly following a woman from the Orange Line and sexually abusing her in an elevator at a nearby building. At the time of this incident, the offender was out on bail on charges related to unlawfully videotaping female customers as they ascended stairs at two Red Line stations earlier in the year.

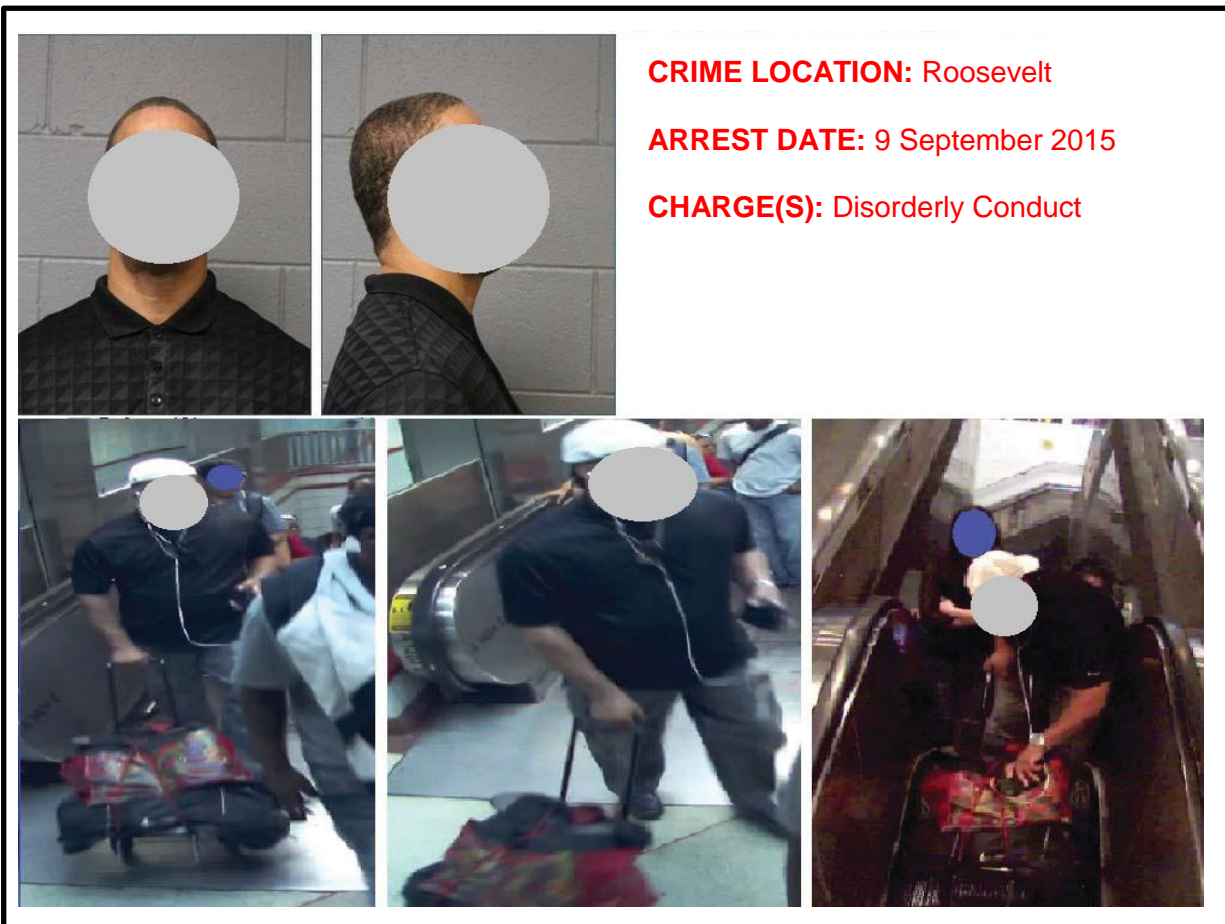

After receiving a report of a man inappropriately touching and pushing into another rider on two separate occasions. Investigators were able to use information provided by the victim to review surveillance footage and pull images of the suspect, which aided in the apprehension and charging of the offender in both incidents.

CHARGE(S): Disorderly Conduct

Police were able to use images pulled from CTA surveillance cameras as part of their investigation into a report of a man using his cell phone to unlawfully take inappropriate pictures of another rider ascending the escalator. This person was arrested and charged with disorderly conduct.



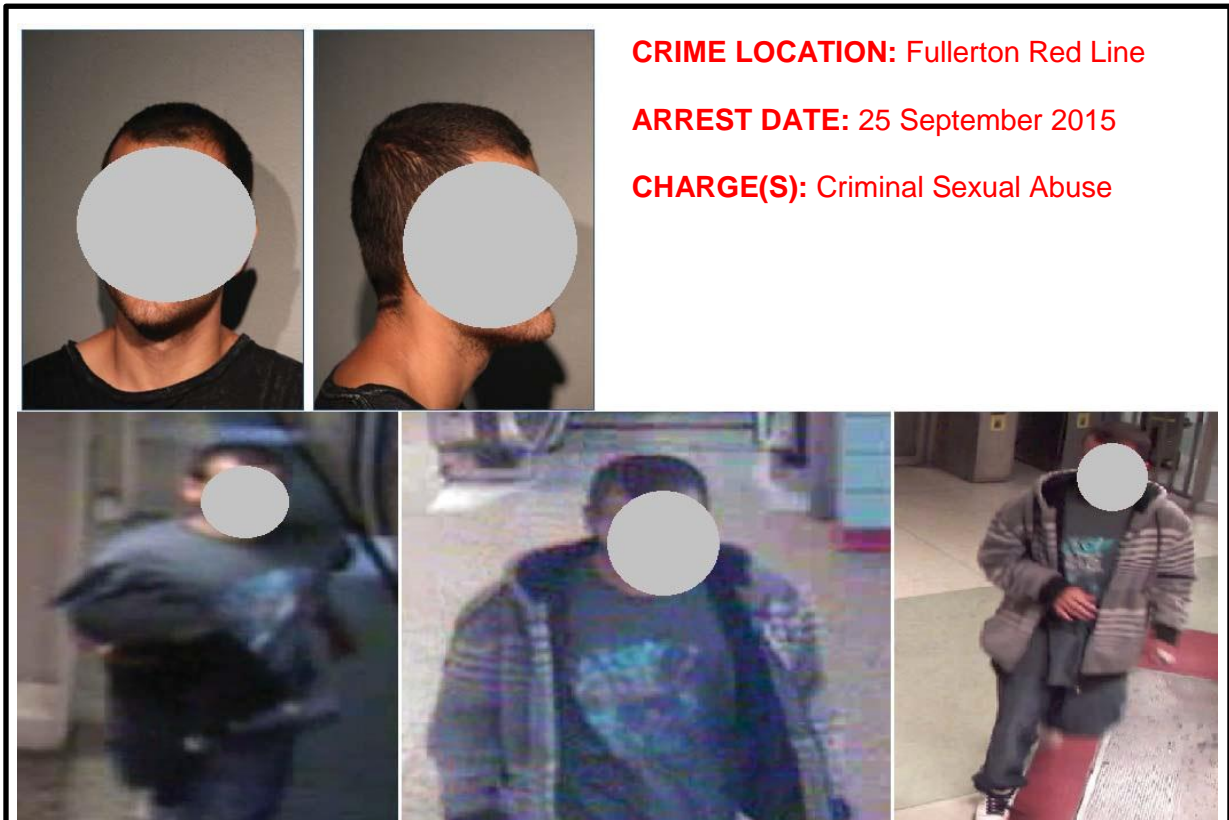

On two separate occasions, CTA riders alerted authorities to a male engaged in a lewd act while on a platform. In both incidents, police responded and arrested the offender. Images pulled from CTA surveillance cameras were used in these investigations, which resulted in the offender being charged with two counts of public indecency.



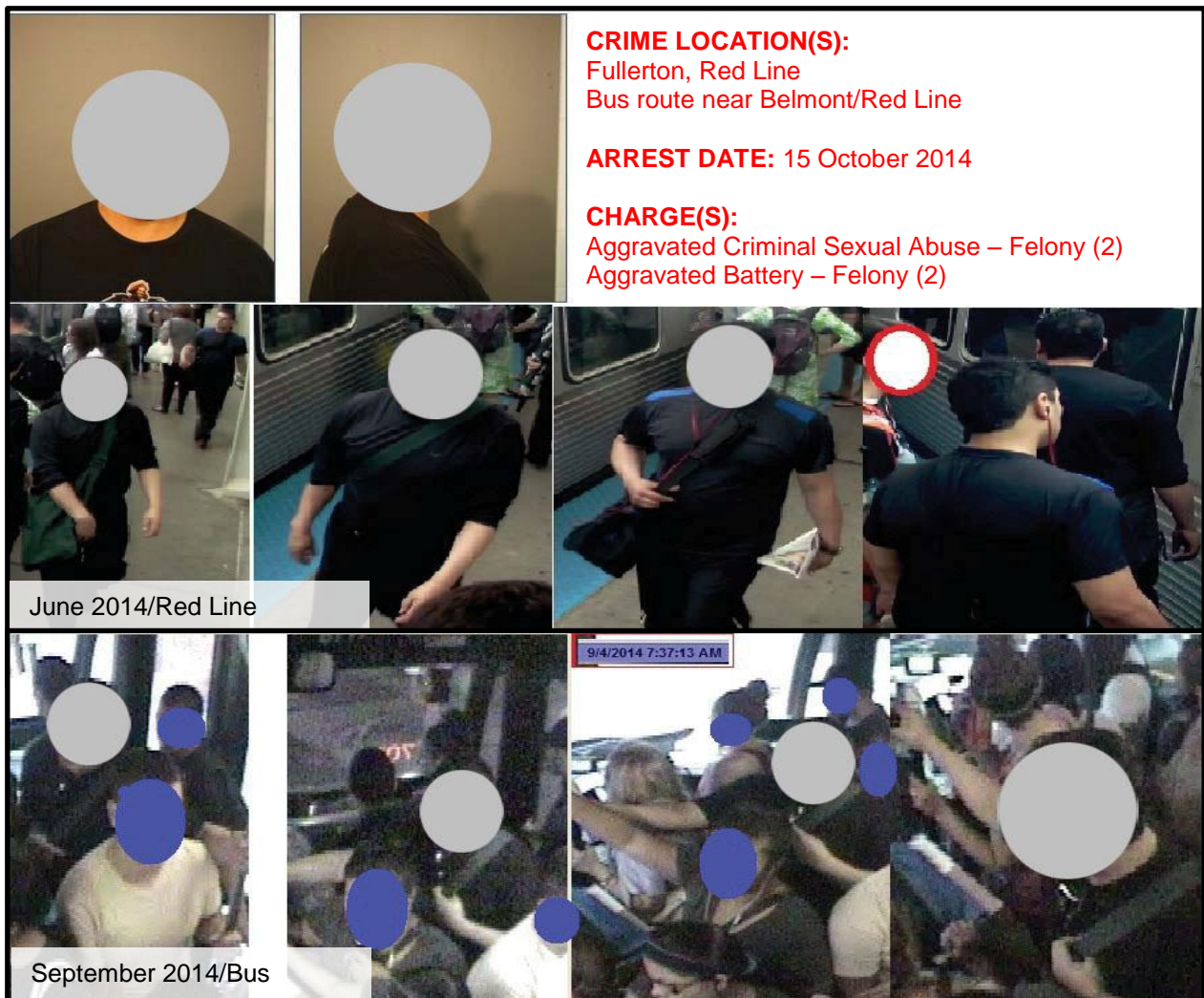

A female rider reported to authorities that after an unknown male confronted her, he then grabbed her from behind and touched her inappropriately. Using images pulled from CTA surveillance cameras as part of the investigation, the next day police were able to apprehend and charge the offender with criminal sexual abuse.









June 2014/Red Line

Offender has been charged with sexually abusing two women in separate incidents that occurred on a crowded Red Line train in June 2014 and on a crowded bus serving the Belmont Red Line station in September 2014. Images pulled from CTA's bus and rail system camera networks were used as part of the investigation, leading to the identification, arrest and charging of this person.

After receiving two reports that an unknown male had pressed himself against two females on the Red and Blue lines in September 2014, police contacted CTA security personnel to review rail system surveillance footage. Images of the suspect were issued to the public, which not only resulted in the suspect being identified by a coworker, but also another victim who reported similar actions made by this person in a separate incident. The third victim positively identified the suspect in a line up and he has since been arrested and charged in these cases.
