Surveillance footage from the Belmont Red/Brown/Purple line station was used as part of the investigation, which led to the identification, arrest and charging of the above offender for multiple robberies.</p>

Surveillance footage from multiple rail stations and rail cars was used as part of this investigation, which led to the identification, arrest and charging of the above seven offenders.</p>

<p>A CTA bus operator reported that a male rider boarded the bus and began arguing with him, at which time the man allegedly spit on the operator. Police were summoned and were able to locate the offender who was found to have a handgun in his possession. The offender was arrested and charged with aggravated battery to a transit employee.</p>

A male rider near the entrance to the UIC-Halsted Blue Line station reported that an unknown male approached and inquired about his cell phone. A second male offender appeared, displayed a knife and the two took the victim's cell phone before fleeing. Rail station surveillance footage was used as part of the investigation, which resulted in the identification, arrest and charging of both offenders.

<p>A student was waiting for the bus when she was approached by multiple female students who then hit her and took her cell phone by force. Surveillance footage from a CTA bus in the area at the time of the incident was used in the investigation of this crime, which led to the identification, arrest and charging of the above offenders.</p>

Surveillance footage from the station was used as part of the police investigation, which led to the identification, arrest and charging of the offender with aggravated criminal sexual abuse.</p>

<p>Surveillance footage from the CTA Montrose Brown Line station was made part of the investigation of a taxi driver who was shot and killed during an armed robbery while in his vehicle. In February 2016, police were able to make an arrest and file first-degree murder charges after substantial evidence, including CTA surveillance footage, linked the above offender to the crime.</p>

	<p>LOCATION: Narragansett/Wabansia</p> <p>ARREST DATE: 20 April 2016</p> <p>CHARGE(S): Aggravated Battery – Transit Employee</p>
<p>A CTA bus operator reported seeing a male rider avoid paying fare by entering through the back doors of the bus, and in doing so he also knocked down a toddler in the aisle. When confronted, the offender and his peers beat the bus operator. Surveillance footage from the bus was used as part of the investigation, which led to the identification, arrest and charging of these four persons.</p>
