

ORDINANCE NO. 018-117

AN ORDINANCE AUTHORIZING
AWARD OF A CONTRACT TO
ELEVATED SOLUTION PARTNERS, A
JOINT VENTURE OF ARCADIS U.S.,
INC., ARDMORE RODERICK, AND
JACOBS ENGINEERING GROUP INC.,
FOR OWNER'S REPRESENTATIVE
CONSULTING SERVICES FOR THE
RED AND PURPLE MODERNIZATION
(RPM) PHASE ONE PROJECT

WHEREAS, The Chicago Transit Authority ("Authority") is undertaking a project to rebuild stations and rail infrastructure on the Red and Purple Lines, also known as the Red and Purple Modernization Project ("RPM"); and

WHEREAS, The Authority seeks Owner's Representative consulting services for the RPM Phase One design-build project to provide direct oversight of the RPM Phase One Design-Build Contractor including design and construction management services, field support services, project controls services, Safety and Security Certification oversight, system safety and security oversight, quality assurance services, and closeout services from Notice to Proceed through construction closeout; and

WHEREAS, The Authority, through public advertisement under Requisition No. C18FT102164819, sought Letters of Interest and Qualifications (LIQ) from qualified firms to act as the Owner's Representative; and

WHEREAS, Elevated Solution Partners, a joint venture of Arcadis U.S., Inc., Ardmore Roderick (DBE), and Jacobs Engineering Group Inc., was determined to be the most qualified for the services by the Authority, and the Authority has successfully completed contract negotiations; and

WHEREAS, Staff recommends award of a contract to Elevated Solution Partners for a term of seven (7) years with three (3) one-year options for a total amount not to exceed One Hundred Two Million Three Hundred Sixty-Eight Thousand Four Hundred Ninety-Seven Dollars and Eighty-Six Cents (\$102,368,497.86); now, therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD
OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. The Chairman of the Chicago Transit Board, or his designee, is hereby authorized to enter into a contract with Elevated Solution Partners, a joint venture of Arcadis U.S., Inc., Ardmore Roderick (DBE), and Jacobs Engineering Group Inc., for Owner's Representative services for Phase One of the Red and Purple

Modernization Project for a term of seven (7) years with three (3) one-year options for a total amount not to exceed One Hundred Two Million Three Hundred Sixty-Eight Thousand Four Hundred Ninety-Seven Dollars and Eighty-Six Cents (\$102,368,497.86).

SECTION 2. The Chairman, or his designee, is further authorized to take such actions and execute such documents as may be necessary to implement the objectives of this ordinance.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
