The original contract amount consists of the Base Order for 400 railcars. Four additional options are available for exercise; Option No. 1 for 156 railcars, Option No. 2 for 100 railcars, Option No. 3 for 100 railcars, and Option No. 4 for 90 railcars.

This Change Order No. 3 consists of the following 2 items:

- 1. Battery Trainline Fuse Replacement \$121,171.00
- 2. Change from Rocket Router to Cradlepoint and GPS Additions \$1,849,200.00

The objective is to implement signal upgrades to the remaining eight miles of the Blue Line signal system, including new special track work to facilitate train movements at Foster Middle Track. The circumstances said to necessitate the change in performance were not foreseeable at the time the contract was executed and the CTA has determined that this Change order No. 1 is in the best interest of the Authority. This change order consist of the following item: Nagle Curve Rail Replacement 1. Proceed Order No. 1
