

ORDINANCE NO. 022-91

AN ORDINANCE AUTHORIZING A
CHANGE ORDER TO A CONTRACT
WITH SVANACO, INC. D/B/A
AMERICANEAGLE.COM FOR
WEBSITE HOSTING SERVICES

WHEREAS, The Chicago Transit Authority ("Authority") requires hosting services, maintenance, and enhancements for all Authority customer websites; and

WHEREAS, On February 8, 2016, the Authority entered into a contract with Svanaco, Inc. d/b/a Americaneagle.com under Requisition No. B15OP03418 for the required services for three years with two funded one-year options for the not-to-exceed amount of \$1,678,500.00; and

WHEREAS, The Authority previously extended the contract for one year via letter, and the Transit Board approved Change Order No. 1 to add funding in the amount of \$335,700.00, per Ordinance No. 020-116; and

WHEREAS, On January 12, 2022, the Board approved Change Order No. 2 authorizing an additional six-month time extension and additional funding in the amount of \$198,000.00, per Ordinance No. 022-12, to provide additional time for the procurement of a new contract, which was presented to the Sole Source Disadvantageous Review Committee (SDRC) for review and approval; and

WHEREAS, Staff is requesting an additional time extension of three months to provide time to complete the procurement process and ensure that service is uninterrupted through the transition to the new contract; and

WHEREAS, Change orders for contracts originally valued at more than \$1,000,000.00 that individually or cumulatively increase the original contract value by more than 10% or by more than \$500,000.00 or extend the original termination date by more than twelve months require approval by the Transit Board; and

WHEREAS, Staff recommends approval of Change Order No. 3 to the contract with Svanaco, Inc. d/b/a Americaneagle.com for website hosting services to extend the contract for three months and add \$84,000.00 in additional funding; now, therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD
OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. The Chairman of the Chicago Transit Board, the President of the Authority, and the Vice President of Purchasing and Supply Chain, or their designees, are hereby authorized to execute Change Order No. 3 to the Authority's contract with

Svanaco, Inc. d/b/a Americaneagle.com for hosting services, maintenance, and enhancements for Authority customer websites to extend the contract for three (3) months and add Eighty-Four Thousand Dollars (\$84,000.00) in additional funding, for a revised contract amount of Two Million Two Hundred Ninety-Six Thousand Two Hundred Dollars (\$2,296,200.00).

SECTION 2. The Chairman, President, and Vice President of Purchasing and Supply Chain, or their designees, are further authorized to take such actions and execute such documents as may be necessary to implement the objectives of this ordinance.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
