WHEREAS, Mr. Longhini was a driving force in the development and implementation of the website that makes all Transit Board ordinances accessible to the public; and

WHEREAS, Mr. Longhini has always approached his role with professionalism, enthusiasm, dedication, and good humor; and

WHEREAS, Mr. Longhini is extremely knowledgeable on the history of the City of Chicago and enjoyed sharing that knowledge; and

WHEREAS, Mr. Longhini has played an essential role in the implementation and administration of the ethics training for CTA officers and employees; and

WHEREAS, Over the past twenty-four years, Mr. Longhini has attended and moderated over 300 meetings of the Transit Board and its Committees and the CTA's Citizen Advisory Board; and

WHEREAS, Throughout his years serving as Assistant Secretary to the Transit Board, Mr. Longhini has demonstrated a passion for ensuring the public's access to information and has worked tirelessly to ensure the ability of the public to voice their concerns to the Board; and

WHEREAS, Mr. Longhini valued his responsibilities involving communicating with the public and would even meet with the public outside of CTA's offices, such as transit stations, to ensure that their voices would be heard, and ensured that he or his staff followed up with concerned citizens on all open issues; and


WHEREAS, Mr. Longhini has announced his retirement from his position as Assistant Secretary; now, therefore:
