AN ORDINANCE AUTHORIZING A CHANGE ORDER TO A CONTRACT WITH DATASKILL, INC. FOR LICENSES, MAINTENANCE, AND SUPPORT FOR IBM SOFTWARE

WHEREAS, On January 1, 2022, the Chicago Transit Authority ("Authority") entered into a contract with Dataskill, Inc. under Requisition No. B21OP00412 for licenses, maintenance, and support for IBM computer operating and subsystem software required to support the Authority's ERP application portfolio, including Oracle ERP, MMIS, AVAS, Planning, E-link intranet and portal, and additional systems, for one year for the amount of \$88,463.38; and

WHEREAS, A six-month extension of the contract was issued via letter to provide time to re-advertise for this service, evaluate responses, and award a new contract, and staff is requesting additional funds in the amount of \$48,011.44 for the extension period; and

WHEREAS, Change orders for contracts originally valued at \$1,000,000.00 or less that individually or cumulatively increase the original contract value by more than 10% require approval by the Transit Board; and

WHEREAS, Change orders for contracts that are not contracts for Public Works Projects that individually or cumulatively increase the original contract value by more than 50% are permitted only when the Transit Board determines that the change order is in the best interest of the Authority; and

WHEREAS, Staff recommends approval of Change Order No. 1 to the contract with Dataskill, Inc. for licenses, maintenance, and support for IBM software to add \$48,011.44 in additional funding for the six-month extension period; now, therefore:

BE IT ORDAINED BY THE CHICAGO TRANSIT BOARD OF THE CHICAGO TRANSIT AUTHORITY:

SECTION 1. Based on the statements set forth in the recitals of this ordinance, the Chicago Transit Board hereby determines that it is in the best interest of the Authority to authorize Change Order No. 1 to the contract with Dataskill, Inc. for licenses, maintenance, and support for IBM software.

SECTION 2. The Chairman of the Chicago Transit Board, the President of the Authority, and the Vice President of Purchasing and Supply Chain, or their designees, are hereby authorized to execute Change Order No. 1 to the Authority's contract with Dataskill, Inc. for licenses, maintenance, and support for IBM software to add Forty-Eight Thousand Eleven Dollars and Forty-Four Cents (\$48,011.44) in additional funding, for a

revised contract total of One Hundred Thirty-Six Thousand Four Hundred Seventy-Four Dollars and Eighty-Two Cents (\$136,474.82).

SECTION 3. The Chairman, President, and Vice President of Purchasing and Supply Chain, or their designees, are further authorized to take such actions and execute such documents as may be necessary to implement the objectives of this ordinance.

SECTION 4. This ordinance shall be in full force and effect from and after its passage.
